Class 6 Three blooms Medium Decorative Dahlias
Class 7 Three blooms Medium Cactus and/or Semi Cactus Dahlias
Class 8 Five blooms Small Decorative Dahlias
Class 9 Five blooms Small Cactus and/or Semi Cactus Dahlias
Class 10 Five blooms Miniature Decorative Dahlias
Class 11 Five blooms Miniature Cactus and /or Semi Cactus Dahlias
Class 12 Five blooms Small Ball Dahlias
Class 13 Five blooms Miniature Ball Dahlias
Class 14 Five blooms Waterlily Dahlias
Class 15 Five blooms Collerette Dahlias
Class 16 Three blooms Fimbriated Dahlia
Class 17 Six blooms Pompon Dahlia
Class 18 Three blooms Large Pompom Dahlia.
